Question September 19, 2024

Would we use a portion of the JAG funding to fund subscriptions to Flock hardware we're already using? The \$50K minimum might outstrip the need for *more* hardware, so there's interest in allocating some of it to their existing hardware.

Response

Please take into consideration *supplanting* when existing hardware or any existing proposed budget items are being request in your application for JAG funding. Supplanting is prohibited with JAG funding. To see if your situation applies, I recommend looking at the following links.

What is supplanting and do supplanting prohibitions apply to JAG funding? Supplanting is to deliberately reduce state or local funds because of the existence of federal funds. For example, when state funds are appropriated for a stated purpose and federal funds are awarded for that same purpose, the state replaces its state funds with federal funds, thereby reducing the total amount available for the stated purpose. JAG funds may not be used to supplant state or local funds but must be used to increase the amounts of such funds that would, in the absence of federal funds, be made available for criminal justice activities or civil proceedings. For additional information, see the DOJ Grants Financial Guide. Although supplanting is prohibited, the leveraging of federal funding is encouraged.
